1. The property that this Amendment shall apply to shall be the same property, and is subject to the Declaration, and is therefore described at Exhibits A and C hereto.
2. The first paragraph of Section 6.5, "Working Capital Assessment," under ARTICLE VI, is hereby eliminated, and in its' place and stead, a new paragraph 6.5 shall be stated as follows:

6.5 Working Capital Assessment. Upon recording of a deed transferring ownership of a lot, the initial purchaser/Owner of such improved Lot shall pay to the Association an initial Working Capital Assessment, which shall be an amount equal to three (3) months installments of the Annual Assessment in effect for the year in which the sale occurs. The Working Capital Assessment amount will be paid upon closing on the sale of the Lot from the Declarant, or Declarant's assigns. The Declarant, or Declarant's assigns shall not be required to pay a capital assessment. The Working Capital Assessment shall only apply once with regard to each Lot and shall be paid in accordance with the provisions of this

paragraph. Payment of this amount shall be in addition to (and not in lieu of) the Annual Assessment due hereunder and shall not be considered an advance payment of any assessment.

3. Section 8.3 entitled "Review of Plans and Specifications," under ARTICLE VIII, shall be amended by adding the following paragraph:

In connection with submitting Plans and Specifications, there shall be a required non-refundable review and inspection fee of \$175 submitted with the Plans and Specifications. The Board may amend that fee from time to time in its discretion by Resolution.

4. The first paragraph of Section 10.3 "Signage; Commercial Activities; Restrictions; Declarant Signs" under ARTICLE X shall be eliminated, and in its place and stead, a new first full paragraph shall be stated as follows:

a) In the case where the owner is selling a lot with a constructed house, the following sign rule shall apply:

Except for one (1) "For Sale" sign of not more than seven (7) square feet, no advertising signs, billboards, or other form of advertisement whatsoever shall be installed, erected, placed, or otherwise displayed on any Lot or any portion of the Properties. Any such signs shall be professionally prepared.

b) In the case of an owner selling a "dirt lot" and/or advertising for the construction of a new home on any lot, the following sign rule shall apply:

Except for one (1) "For Sale" sign, or signs advertising for the construction of a new home of not more than seven (7) square feet, no advertising signs, billboards, or other form of advertisement whatsoever shall be installed, erected, placed, or otherwise displayed on any Lot or any portion of the Properties. The design of any such signs shall be subject to the approval of the Board as to the sign's design, and such approved sign shall be professionally prepared. No sign shall be used prior to obtaining such approval, and complying with the terms of the approval.

5. The first paragraph of Section 10.16, "Landscaping," of ARTICLE X shall be eliminated, and in its place and stead, a new paragraph 10.16 shall be stated as follows:

10.16 Landscaping. Lots shall have front-yard and side-yard(s) landscaping reaching to the rear of the Home, including landscaping of the Park Strips. All front yard landscaping shall be completed on or before issuance of the Certificate of Occupancy.

Rear-yard landscaping, if not completed prior to Certificate of Occupancy, shall be completed thereafter in a period of time not to exceed twelve (12) months after issuance of the Certificate of Occupancy. All front landscaping shall include not less than ten percent (10%) of the area in grass. The balance of front landscaping area shall be in other landscaping elements, such as shrubs, plants, trees, rock, and landscape aggregate, approved by the ACC. Notwithstanding the above, the requirements may be waived or modified by the ACC upon good cause shown.

The First Amendment to the Declaration of Covenants, Conditions and Restrictions and Reservations of Easements for Bella Sol at Santa Clara shall become effective immediately upon recording in the Office of the Washington County Recorder.

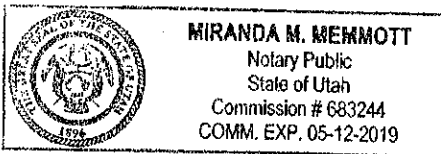
